The Arunachal Pradesh Staff Selection Board conducted the Combined Graduate Level Examination 2025 on 15.06.2025 which was advertised vide Advt. b. Matriculation certificate issued by the Board / University for proof of date of birth.

c. Graduation certificate issued by the Assistant Registrar/ Controller of Examination/ Vice Chancellor of the concerned university.

d. Graduation marksheet issued by the Assistant Registrar/ Controller of Examination/ Vice Chancellor of the concerned university.

e. Diploma Certificate in Stenography from a recognised Institution (wherever applicable)

f. APST Certificate (if applicable).

g. Permanent Resident Certificate (if applicable).

h. Intimation letter to HoD for those who are in regular Govt. Service.

i. PwBD/ PwD Certificate in case of vacancy under PwBD/ PwD quota.

j. Admit Card.

6. Failure to upload documents shall result in rejection of candidature and non-allotment of post.

7. The provisionally shortlisted candidates should bring their original documents and photocopy of the documents mentioned at 5 (a) to 5 (j) along with 02 copies of recent passport size on the day of Document Verification.
