4. The provisionally shortlisted candidates for the posts of Data Entry Operator (Post Code: No. 08/25) and Lower Division Clerk (Post Code: No. 11/25), will have to mandatorily qualify the Skill Test. The scheme of Stage-2 (Skill Test) as advertised vide Advertisement No. 03/2025 dated 23.06.2025 is as under:

## 4.1. Typing Test

"Typing Speed Test of 35 words per minute on computer (35 words per minute corresponds to 10500 Key Depression per hour) (KDPH) on an average of 5 Key Depression for each word. Skill Test will be of qualifying nature only. The marks secured will not be counted for preparation of the final Merit list.

Stage-2 (Skill Test) of the examination is not applicable for candidates for the posts of Agriculture Field Assistant Jr. (AFA Jr.) (Post Code: 07/25), Fishery Demonstrator (Post Code:09/25), Laboratory Assistant (Post Code:10/25), Mandal (Post Code: 12/25), Sanitary Inspector (Post Code:13/25) and Urban Programme Inspector (Post Code:14/25). However, the candidates for these posts must report on the day of Skill Test & Document verification on 20.09.2025 for verification of their documents".

5. The schedule for Skill Test and Document Verification for the provisionally shortlisted candidates is as follows:

- 5.1. The details pertaining to batches, venue and time of Skill Test & Document Verification shall be intimated in due course.
- 6. The provisionally shortlisted candidates shall mandatorily upload their documents by logging into the website <a href="www.apssb.nic.in">www.apssb.nic.in</a> using their credentials from 11.09.2025 (11:00 AM) to 18.09.2025 (03:00 PM). The following documents are to be uploaded:
  - i. Recent passport size Photograph (2 copies).
  - ii. Matriculation certificates issued by the Board/University for proof of date of birth.
  - iii. Class XII pass certificate issued by the Board/University.
  - iv. Class XII marksheet issued by the Board/University.
  - v. APST Certificate (if applicable).
  - vi. Permanent Resident Certificate (if applicable).
  - vii. Certificate of 6 (six) months Diploma in Computer Application from a recognized Board/Institution duly recognized by the Arunachal Pradesh Council for Technical Education/AICTE (if applicable).
  - viii. Certificate Course in GIS/ETS/Total Station/DGPS/Remote Sensing from a government recognized Board/Institute (if applicable).
  - ix. Certificate Course in Laboratory Assistant from a recognized Institution (if applicable).
  - x. Discharge certificate and Pay and Pension (PPO) issued by the Competent Authority for Ex-Serviceman.
  - xi. Intimation letter to HoD for those who are in regular Govt. Service.
  - xii. PwBD certificate in case of vacancy under PwBD quota.
  - xiii. Admit Card and printout of online application form.
  - xiv. Any other documents as may be relevant.



7. Failure to upload documents shall be liable for rejection of candidature and non-allotment of post.

8. The provisionally shortlisted candidates should bring their original documents and photocopy of the

documents mentioned at 6 (i) to 6 (xiii) on the day of Skill Test and Document Verification.

9. The candidature of all the shortlisted candidates is PROVISIONAL and subject to their

eligibility in all respects as prescribed in the Advertisement and Recruitment Rules.

10. Candidates must note that their candidature is purely provisional at this stage and their

appointment will be subject to their name figuring in the final selection list which shall be prepared

after the Skill Test and Document Verification.

11. Apart from that they should fulfill the eligibility criteria as per Advertisement No.03/2025 dated

23.06.2025, including possession of the requisite documents, failing which their candidature may be

summarily rejected at any stage.

12. Further, the Appointing Authority i.e., the indenting / user department shall verify the character

and antecedents of the candidates, authenticity of documents/ certificates and eligibility as per the

Recruitment Rules before finally appointing the candidate(s).

13. Therefore, the provisional shortlisting of a candidate does not confer upon him/ her any right of

appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered

necessary, that the candidate is suitable and eligible in all respects for appointment to the post.
