#### **NOTIFICATION**

The State Council of Educational Research & Training (SCERT), Govt. of Arunachal Pradesh, Itanagar is conducting the 12th State Level Teacher Eligibility Test (APTET), 2023 in accordance with the provisions of Section 23 (I) of RTE Act 2009 as it is one of the eligibility criteria under NCTE Guidelines for the person aspiring to become teacher at Elementary Level in the schools of Arunachal Pradesh.

A candidate applying for APTET'2023 should meet the following criteria/requirements:

## A. PAPER - I (Class I to V) Primary Level: -

- 1. Maximum Age 30 years as on 30/11/2024 (age relaxation to APST candidates as per norms).
- 2. Educational Qualifications: -

Senior Secondary (or its equivalent) with 50% marks and 02-year Diploma in Elementary Education (by whatever name known)

Senior Secondary (or its equivalent) with at last 50% marks and 04-year Bachelor of Elementary Education (B.El.Ed)

Senior Secondary (or its equivalent) with at least 50% marks and 02-year Diploma in Education (Special Education)

OR

Graduation with at least 50%- and 02-year Diploma in Elementary Education (by whatever name known)

OR

Graduation with at least 50% marks and Bachelor of Education (B.Ed)

OR

Post-Graduation with a minimum 55% marks or equivalent grade and 03-year integrated B. Ed.- M. Ed

### B. PAPER – II (Class VI to VIII) Upper primary Level: -

- 1. Maximum age 35 years as on 30/11/2024 (age relaxation to APST candidates as per norms).
- 2. Educational Qualification: -

Graduation and 02-year Diploma in Elementary Education (by whatever name known)

Graduation with at least 50% marks and 01-year Bachelor in Education (B.Ed)

OR

Graduation with at least 45% marks and 01-year Bachelor in Education (B.Ed), in accordance with the NCTE (Recognition Norms and Procedure) Regulations issued from time to time in this regard

Senior Secondary (or its equivalent) with at least 50% marks and 04-year Bachelor in Elementary Education OR

Senior Secondary (or its equivalent) with at least 50% marks and 04-year B.A, B.Ed or B.Sc, B.Ed OR

Graduation with at least 50% marks and 01-year B.Ed (Special Education)

Graduation with at least 45% marks and 01 year Bachelor in Education (B.Ed)

- 3. Qualifying Marks: A candidate has to secure 60% or above to qualify the APTET and a Certificate shall be
- 4. **Relaxation**: Upto 5% in qualifying marks for the candidates of reserved category as per State Govt. norms.
- 5. D.El.Ed/B.Ed. Course from NCTE recognized institutions and Diploma in Special Education and B.Ed (Special Education) organized by rehabilitation council of India (RCI) shall only be considered.

Answer key challenge: The provisional answer key shall be uploaded in the website <a href="https://arunachaltet.in">https://arunachaltet.in</a> and in the SCERT website for 24-hour period after the exam. Candidates can challenge the answer key by submitting sufficient references and supporting documents, and on payment of fees of Rs.500/- per challenged question at SCERT, Itanagar. No claim for correction of answer key will be entertained if the same is not supported by authentic and specific documents. No challenge will be allowed after the prescribed period of time. Fees of only those candidates whose claims are found to be correct shall be refunded.		

#### N.B:-

- 1. Candidates shall use a working mobile number during the process of filling the APTET form, any information shall be shared in this mobile number. Also, the user id and password used during registration should be preserved carefully for future use.
- 2. Qualifying the APTET'2023 would not confer a right on any person for recruitment/employment as it is only one of the eligibility criteria for appointment.
- 3. It should also be noted that if a candidate has been allowed to appear the APTET'2023, it does not imply that candidate's eligibility has been verified. It does not vest any right with the candidate for appointment. The eligibility shall be finally verified by the concerned recruiting/appointing authority.
- 4. Furnishing of false, wrong or inaccurate information may lead to cancellation of the test result, forfeiture of certificate and even prosecution.
- 5. Only NCTE recognized B.Ed/D.El.Ed certificate shall be considered.
- 6. "Appearing Candidates" means the students of final semester or final year of qualifying examination, only they are eligible to apply for APTET'2023. Such candidates should submit their 3<sup>rd</sup> Semester or 1<sup>st</sup> year passed mark sheet during online form fill up.
- 7. The examination fee should be paid only through the online e-GRAS portal (<a href="https://egras.arunachal.gov.in">https://egras.arunachal.gov.in</a>) of the Government of Arunachal Pradesh. Select Department: State Council of Educational Research and Training (SCERT) and Payment Type / Head of Account: 0202 Education, Sports, Art & Culture, Scheme Name: 0202-01-101-01-01 Examination Fee. This payment process can also be accessed while filling the online APTET form.
- 8. Submission of wrong photograph and details is self-responsibility of candidates and no request for change will be considered after the conduct of examination.
