Candidates should go through the recruitment notice carefully before applying for the respective post and ensure that they fulfil all the eligibility conditions like age/educational and other qualifications/ experience/ category, etc., as indicated against each post in this advertisement. Candidature of candidates shall be purely PROVISIONAL at all stages and any application not meeting the eligibility conditions will be cancelled at any stage of the recruitment process without any notice.

(ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate. OR B. An outstanding professional, having a Ph.D. degree in the concerned discipline for all subjects and allied/relevant disciplines for Tribal Studies, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.
02/A	Associate Professor	Eligibility: i) A good academic record, with a Ph.D. Degree in the concerned discipline for all subjects or allied/relevant disciplines for Tribal Studies. ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed). iii) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of 7 (Seven) publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2. 03/A	Assistant Professor	Eligibility (A or B): A. i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in the concerned discipline for all subjects or allied/relevant disciplines for Tribal Studies from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET: Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which atleast one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her PhD work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

B. The PhD degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) for universities, and Appendix II (Table 3B) for colleges, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview. Relaxation:

A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b)

		Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

Note:

1. The UGC guidelines shall be the ultimate basis of reference if there is any issue with regards to the recruitment of the above mentioned post.
2. The criteria for shortlisting and evaluation will be guided as per the established UGC and state government guidelines.
3. Reservation policy of the Government of Arunachal Pradesh will apply.
4. All relevant documents of qualifications, credentials, experience, publications, etc as claimed must be produced in original at the time of interview for verification.

1. How to Apply: Interested candidates may submit the softcopy of their application in prescribed format as given in the University website www.apupsg.ac.in through email to recruitment@apupsg.ac.in. The email should contain the main application along with self-attested copies of all the relevant documents in a single pdf. The list of documents to be enclosed/uploaded are given in serial no. 8. The subject of email should be written as "Application for the post of _____". The last date of submitting application through email is **10/08/2025 (5:00 pm)**. However, the candidates must bring the original copy of the Application form and other documents during interview.
2. No intimation to candidates will be communicated in case of non-receipt of applications for any reason. The Arunachal Pradesh University, Pasighat will NOT be responsible for any such eventuality.
3. Incomplete applications and/or applications received after due date shall summarily be rejected and no further correspondence in this matter shall be entertained.

5. Candidates applying for more than one Department and/or position are required to submit separate application forms.
6. Notification of Eligible/Shortlisted candidates: To be notified in the notice board/website of the Arunachal Pradesh University, Pasighat on 19 August (Tuesday), 2025 after 2 pm. Candidates are requested to visit the University website for any updates, subsequent amendments in the advertisement and results. No separate call letters or admit cards will be sent for appearing in the interview.
7. Date of Interview: Tentatively, the date of Interview for different subjects may vary from a minimum of 10 days to a maximum of 30 days from the date of notification of eligible candidates.
8. The following documents are to be emailed along with the Application form.

9. Applications received in response to the advertisement for the above mentioned posts will be scrutinized and short-listed candidates only will be called for interview. Mere fulfilment of minimum eligibility criteria laid down in the advertisement does not entitle automatically a candidate to be called for interview. The decision of the University for short-listing of candidates shall be final and binding. The University reserves the right to restrict the number of candidates to a reasonable limit on the basis of academic qualifications, reputations of institutions studied, work experience, quality of research publications, and specific requirements of the individual departments. No correspondence whatsoever will be entertained from candidates regarding the reason for not being called for the interview/outcome of the interview.
10. More than six months of experience in a regular position with a pay scale in an organization is necessary to be considered as work experience. Experience rendered on part-time, daily wages, or as visiting guest faculty will not be counted as work experience. The experience certificates attached with the application must clearly show the period of service and the scale of pay during the service with the organization to ascertain the actual work experience of the candidate.

11. All original documents including valid ID proof will have to be produced at the time of interview.
12. APST candidates should submit a copy of relevant caste/community certificate along with their application. Application without any caste/community certificate will be considered in the General category.
13. Persons with disability (PwD) are required to submit the Disability/Medical Certificate in the performa prescribed and issued by the competent medical authorities for the purpose of employment as per Government of Arunachal Pradesh norms with duly completed application form.
14. The institute shall retain the applications of non-shortlisted candidates and non-selected candidates only for six months after the completion of the recruitment process.
15. Canvassing in any form would lead to disqualification of candidature.
